Application to Conduct Open Burning
(Land Clearing Debris Only)

The following conditions must be met:

- 1. No trash, asphaltic, rubber or plastic materials are to be burned.
2. No construction or demolition debris are to be burned.
3. There is no practical alternative disposal method for the vegetation to be burned.
4. The vegetation must be grown on the premises and thoroughly dried, at least 10 days.
5. Burning must be conducted during daylight hours only. Fires must be completely extinguished and not allowed to smolder overnight.
6. Give careful consideration to the effects, or potential effects, on other people or property. Time of day, proximity, type of materials, wind direction and other weather conditions have a bearing on the effect to others.
7. No trunks, limbs or stumps over 8 inches in diameter (before splitting) are to be burned. The open burning of roots and stumps mixed with dirt is prohibited.
8. All burning must comply with Division of Air Quality Rules and the enclosed pamphlet.
9. A permit must be obtained from the Division of Forestry during forest fire season (March 1 - May 31 and October 1 - December 31) to burn between the hours of 7:00 a.m. and 5:00 p.m. Copy of Forestry permit must be submitted with this application.
10. If complaints are received, burning must cease immediately and a pit burner may be required.

In addition, this approval is subject to the condition checked below:

- [ ] A pit burner must be used for burning all vegetation at this site. Setup and operation of the pit burner must be in conformance with manufacturer's specifications.

Note that the Division of Forestry also requires all combustible materials be removed at least 10 feet from material to be burned and that someone must attend the fire at all times.
