KEYBOARD(Company Name) is providing notice to the general public of its proposal to use ERCs pursuant to the provisions of 45CSR28, "Air Pollutant Emissions Banking and Trading". This rule provides for a voluntary open-market emission trading program for volatile organic compounds as a class of compounds, oxides of nitrogen as an ozone precursor, and all criteria pollutants, except ozone. Sources that produce more costeffective pollution control techniques and which over-comply with state and federal air standards can generate ERCs and market them to sources with high costs of compliance so they may realize a cheaper compliance option that achieves equivalent or greater overall emission reductions on a statewide basis. While providing incentives to make progress towards the attainment or maintenance of air quality standards, 45CSR28 has provisions that ensure no increase in actual emissions of hazardous air pollutants (HAPs) and that act as safeguards to protect human health, welfare, and the environment. 45CSR28 requires the DAQ to make a determination as to the completeness of the submittal within 60 days of receipt of the proposed Notice of Emission Reduction Credits Use or Retirement. This determination of completeness or incompleteness is considered a final agency decision.

This notice provides an opportunity for the public to review the basis, including calculations demonstrating compliance through the use of emission reduction credits, for the proposed ERC use by KEYBOARD(company name). In the event you wish to submit written comments addressing this agency action, please identify the name of the company, DAQ facility identification number, pollutant(s), and Registry ERC Series Number(s) proposed to be used your comments are intended to address; include your name, a return address, and a daytime telephone number in the event this Office should need to contact you regarding your submittal; and indicate any organization on behalf of which your comments are submitted. All written comments pursuant to this notice must be received by the DAQ within thirty (30) days of the date of publication of this notice. In the event the 30th day is a Saturday, Sunday, or legal holiday, the comment period will be extended until 5:00 p.m. on the following regularly scheduled business day. All public comments are a part of the public record and are available for inspection by any interested party.

The DAQ, prior to making its determination of completeness, will consider only those written comments relevant to air quality issues pertaining to the requirements of 45CSR28, and that are received within the time frame specified above and at the address noted below.

Copies of the Notice of Emission Reduction Credit Use, absent any information defined as being confidential in accordance with the requirements of 45CSR31, along with any supplemental materials are available for public review at the address below between the hours of 8:00 a.m. and 5:00 p.m., Monday through Friday, holidays excluded.
