For Final Minor Modification Permitting Action Under 45CSR30 and Title V of the Clean Air Act

Facility Description

The Willow Island Power Station is a fossil fuel fired electric generation facility with a 55 (net) MW unit and a 188 (net) MW unit and operates under Standard Industrial Classification (SIC) code 4911. The facility consists of a 619 mmBtu/hr coal-fired boiler, a 1605 mmBtu/hr coal-fired boiler, two 19.89 mmBtu/hr oil/natural gas-fired auxiliary boilers, one 4.22 mmBtu/hr diesel-fired emergency generator, one (1) 340 hp diesel-fired fire pump, and various supporting operations such as coal handling, ash handling and various tanks with insignificant emissions. The facility has the potential to operate seven (7) days per week, twenty-four (24) hours per day and fifty-two (52) weeks per year.

The proposed Title V modification is for the separation of the Pleasants Power Station and Willow Island Power Station from one permit into a two-part permit.

Emissions Summary

There are no changes in emissions associated with this minor modification.

Title V Program Applicability Basis

With the proposed changes associated with this modification, this facility maintains the potential to emit 92,579 tons per year of SO₂, 47,204 tons per year of NO_x, 3,005 tons per year of PM₁₀, 1,517 tons per year of CO, 189 tons per year of VOC, and 5,563 tons per year of HAPS. Due to this facility's potential to emit over 100 tons per year of criteria pollutant, over 10 tons per year of a single HAP, and over 25 tons per year of aggregate HAPs, Pleasants/Willow Island Power Station is required to have an operating permit pursuant to Title V of the Federal Clean Air Act as amended and 45CSR30.

Legal and Factual Basis for Permit Conditions

The State and Federally-enforceable conditions of the Title V Operating Permits are based upon the requirements of the State of West Virginia Operating Permit Rule 45CSR30 for the purposes of Title V of the Federal Clean Air Act and the underlying applicable requirements in other state and federal rules.

The modification to this facility has been found to be subject to the following applicable rules:

Federal and State: 45CSR30 Operating permit requirement.

State Only: N/A

Each State and Federally-enforceable condition of the Title V Operating Permit references the specific relevant requirements of 45CSR30 or the applicable requirement upon which it is based. Determinations and Justifications

The Pleasants Power Station and the Willow Island Power Station are physically two separate facilities. For Title V purposes, they are contiguous, operate under the same SIC code and are under common ownership and control. Therefore, they both operate under one Title V permit. Allegheny Energy Supply Company, LLC has requested this minor modification to separate the single Title V permit into a two-part permit to facilitate a seamless transfer of the Pleasants Power Station portion of the Title V permit to a

potential buyer. There are no physical changes or changes in the method of operation associated with this permit modification.

The permit number will remain the same with the addition of "(1 of 2)" for the Pleasants Power Station and "(2 of 2)" for the Willow Island Station.
