Title V Program Applicability Basis

With the proposed changes associated with this permitting action, this facility maintains the facility-wide potential to emit over 10 tons per year of a single HAP. Therefore, Optima Belle is required to have an operating permit pursuant to Title V of the Federal Clean Air Act as amended and 45CSR30.

Legal and Factual Basis for Permit Conditions

The State and Federally-enforceable conditions of the Title V Operating Permits are based upon the requirements of the State of West Virginia Operating Permit Rule 45CSR30 for the purposes of Title V of the Federal Clean Air Act and the underlying applicable requirements in other state and federal rules.

Determinations and Justifications

MM03 changes due to R13-0882N

1. Updated the R13-0882 permit number and issuance date in Section 1.2.
2. Added Condition 4.1.2.13.1 to require that the main scrubber (003), incinerator (009), and incinerator scrubber (010) be used at emission point 104.014 during all periods of the Negolyte process. Also added that the dust collector 115 be employed by emission point 104.003B to minimize particulate emissions generated during periods in which solids are charged to the reactor. A limit for the total batches has also been added.
3. Added Condition 4.1.2.13.2 to require specific emissions limits for Particulate Matter, VOC's, Catechol, Toluene, Hydrogen Chloride, Titanium Tetrachloride, and total HAPs for the Negolyte process. R13 PM limits for the Negolyte process are more stringent than the 45CSR§7-4.1 limit, therefore a streamlining note was added to the citation.
4. Added "R13-0882N" to Condition 3.1.10.
5. Added R13-0882 citation to Title V Condition 4.1.10.
6. Corrected the emission point of the dust collector from 115A to 115 in Condition 4.1.2.7.1.
