Proposed Activity: DAQ 2022 Legislative Rules **Project Description:** The DAQ proposed 2022 legislative rules include:

45CSR8 (Ambient Air Quality Standards)
45CSR16 (Standards of Performance for New Stationary Sources)
45CSR18 (Control of Air Pollution from Combustion of Solid Waste)
45CSR34 (Emission Standards for Hazardous Air Pollutants)

Upon authorization and promulgation of the final rules, 45CSR16 and 45CSR34 will be submitted to the United States Environmental Protection Agency (EPA) to fulfill federal obligations under the Clean Air Act (CAA), including delegations and authorizations. Upon authorization and promulgation, 45CSR8 will be submitted to EPA for approval as a revision to the State Implementation Plan (SIP) pursuant to the federal CAA. Upon authorization and promulgation, 45CSR18, will be submitted to EPA for approval as a revision to the CAA §111(d)/129 State Plan to fulfill federal obligations.

Public Hearing: July 6, 2021 at 6:00 p.m.

The purpose of the public hearing is to receive comments concerning the proposed DAQ 2022 legislative rules identified above. Comments will be responded to in writing later as part of the rulemaking process. A separate hearing will be held for each of the proposed rules. The hearings will be held sequentially and will commence immediately following the conclusion of the hearing for the previous proposed rule.
