**APPROVED**  
**CONTINUING EDUCATION/RECERTIFICATION CLASSES**  
**February 13, 2018**

**All workers must have completed 16 hours of continuing education training courses approved by the Secretary for each class of certification for license renewal. All workers must have at least 8 hours of course credit from the regular course category. No more than 8 hours credit from the safety category will be approved for each certification renewal period. However, an 8-hour safety course can be taken and used for multiple certifications (i.e. A class A and Class C worker could take 8 hours of Class C work, 8 hours of Class A work, and then use 8 hours of safety to meet the 16-hour requirement for both Class A and Class C).**

NOTE: Only courses on this list have been approved by WVDEP for UST Worker continuing education. Course Certificates MUST contain the course title, number of hours of continuing education credit as approved by WVDEP, the WVDEP provided course number, participant's name and UST certification number(s), and the date and location of the training. If the certificates do not contain all of the above-mentioned information, the course will not be accepted for WVDEP UST Worker continuing education.
