The West Virginia Department of Environmental Protection's Division of Air Quality (DAQ) will hold a virtual public meeting on Thursday, September 21, 2023, to provide information and receive comments regarding W-L Construction & Paving, Inc's air quality general permit registration application G20-C041.W-L Construction & Paving, Inc's Millville Facility has proposed to replace their existing HMA plant with a newer model hot mix asphalt plant. The facility is located at Bradstone Lane, Millville, WV 25432, latitude 39.29680 degrees N and longitude -77.79510 degrees W.

The DAQ will hold the public meeting virtually at 6:00 p.m. on Thursday, September 21, 2023. Instructions for asking questions and providing oral comments at the virtual public meeting are provided below. DAQ staff members will be available to provide a presentation and answer questions before taking comments from the public. The public comment period has been extended to 5:00 p.m. on Friday, September 22, 2023.
