WV Code 22-4-24(c)(3) allows the director to revoke a permit whenever the director discovers a violation of the act, rules, permit conditions, or other order.

Whenever a Quarry Revocation Report is filed, the inspector shall note in the comment section of the MR-10Q a description of the circumstances which should result in the permit being revoked. Appropriate pictures shall be attached. The Inspection and Enforcement Supervisor approval of the recommendation will be indicated by their signature on the MR-10Q. This is a most serious action and should not be taken lightly.

Headquarters Office will send the permittee a letter advising that, if an agreement satisfactory to the Director is not approved within thirty days from the receipt of the letter, the permit will be revoked and the associated bond or Bond Pool deposits will be forfeited.
