# Public Notice Proposed DAQ 2021 Legislative Rules

The West Virginia Department of Environmental Protection (DEP), Division of Air Quality (DAQ) has scheduled a public hearing for its 2021 proposed legislative rules to be held at 6:00 p.m. on Tuesday, July 28, 2020. The public hearing will be held virtually to prevent the spread of COVID-19 in accordance with the Governor's Safer at Home Order and the WVDEP COVID-19 Policy. Instructions for participating and for providing oral comments in the virtual public hearing are provided below.

The public comment period begins June 26, 2020 and ends at the conclusion of the public hearing on July 28, 2020. Written comments may be submitted at any time during the public comment as instructed below. Both oral and written comments will be made part of the rulemaking record. Comments received after the conclusion of the public comment period will not be accepted.

45CSR33 (Acid Rain Provisions and Permits)

45CSR34 (Emission Standards for Hazardous Air Pollutants)

45CSR44 (Control of Greenhouse Gas Emissions from Existing Coal-Fired Electric Utility Generating Units)

Upon authorization and promulgation, 45CSR8 will be submitted to EPA for approval as a revision to the State Implementation Plan pursuant to the federal CAA. Upon authorization and promulgation, 45CSR18, will be submitted to EPA for approval as a revision to the CAA §111(d)/129 State Plan to fulfill federal obligations. Upon authorization and promulgation, 45CSR23 and 45CSR44 will be submitted to EPA for approval as a component of the respective CAA §111(d) State Plans to fulfill federal obligations.
